- to advise on matters affecting confidence in certification, including openness and public perception, and to review the impartiality of the audit, certification and

decision making processes of the certification business of Elite Electronic Engineering, Inc. Ltd.

Membership of the 'Committee for safeguarding impartiality' is open for any individual representing one of the key interests identified by Elite Electronic Engineering, Inc.:

- Clients of Elite Electronic Engineering, Inc. or other certification bodies;
- Representatives of industry trade associations;
- Representatives of governmental regulatory bodies or other governmental services;
- Representatives of non-governmental organizations, including consumer organizations;
- Business or management system consultants;
- Management system auditors;

The members of the 'Committee for safeguarding impartiality' have following duties:

- To advise on matters affecting confidence in certification, including openness and public perception;

- To verify in terms of impartiality auditors, the audit team leaders and technical experts involved in the certification activity;

- To analyze handling of complaints related to certification activity, including impartiality in case of decision related to certification holders;
